The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Starting at the beginning of the school year we promoted and advertised every board meeting to parents to solicit feedback and requests to offer in-person instruction. In addition to board meetings, we sent out multiple parent surveys to determine needs and intentions on returning to school in-person. We also offered two public meetings directed specifically to parents only to discuss the plan for spending ELO grant funds as well as soliciting feedback for the LCAP and plans for next school year. After review of the surveys, emails sent to the school director and public comments made during the board meetings and public meetings, it was decided during the January board meeting, to open up for in-person instruction to start on February 1st. We continued to collect feedback from parents to help build the plan for offering additional supports to students through this additional funding.

A description of how students will be identified and the needs of students will be assessed.

Students have been identified as needing extra academic support based on their iReady assessment scores and by teacher/parent requests. We use the iReady results as an indicator of the students' areas of need. Students who need additional mental health or behavioral support have been identified by their teacher, the counselor, or the parent and have been offered additional support through our tech center for independent learning days and in the classroom for the in-person instruction days.

Parents have been contacted via our messaging platform ParentSquare as well as by email from their child's teacher about our offer of all academic support/summer school/emotional support being offered. In some cases SSTs or IEPs were held and the offer was made at the meeting.

A description of the LEA's plan to provide supplemental instruction and support.

1. NCSA intends to offer a 4 week academic recovery and enrichment program to students who have been identified as needing extra support during summer.
2. NCSA created a community hub center and hired additional paraprofessionals to support students in need and without internet to attend school in our tech center for independent learning days. In addition, we hired additional paraprofessionals for in class learning to support more one-on-one tutoring.
3. Purchased additional iReady licenses for Reading and Math Learning recovery programs and materials designed to accelerate student academic proficiency and provide diagnostic assessment data.
4. Provide Literacy Training for teachers over summer
5. We plan to Hire additional FT school psychologist and general education counselor to help support students mental health next school year.
6. Continue to offer parents access to hotspots if needed in order for students to access iReady during the in-person instruction period and over the summer.
7. Provide training for school staff on social thinking strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

NCSA's largest focus has been on integrating pupil supports by offering additional mental health services through our school counselor. We have also created a tech center to support community learning hubs that provide pupils with access to technology, high-speed internet and one-to-one tutoring with paraprofessional support and supervision. Due to the expense of these items, the ELO grant funds are not enough

so we are also integrating use of supplemental funding and ESSER funds to continue supporting these expenses that are beyond the normal operation of school for this school year and next and to continue in person instruction for students that need it.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education (COE), or charter schools, collectively referred to as LEAs, that receive Expanded Learning Opportunities (ELO) Grant funds under California Education Code (EC) Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
