Sliding Scale Fee Policy

The Raven Wolf Expanded Learning Program is committed to ensuring all students have access to high-quality expanded learning opportunities. In accordance with California ELO-P requirements, foster youth, homeless youth, and students who qualify for Free or Reduced-Price Meals (FRPM) will not be charged program fees.

Families who do not qualify for fee waivers may be eligible for reduced fees based on household income.

Income Verification

Families may demonstrate eligibility through:

- Current pay stubs
- Tax documentation
- Documentation of public assistance benefits
- Self-certification as permitted under ELO-P regulations

Sibling Discount

Families paying full program fees may receive a 10% discount for each additional child enrolled in Raven Wolf programs.
